Send us in your love and mercy, that the world may know you and praise you.



### **WORSHIP & LITURGY**

Worship is at the heart of all we do. Our liturgical life forms the basis of our life together, as we are continually being gathered together around word and sacrament and continually being sent into the world. In addition to our weekly Sunday gatherings, this year's special liturgies included:

• Choral Evensongs (with St. John's Collegium) for the Presentation of Our Lord (Candlemas), held at St. John's and livestreamed on February 1, and for Thanksgiving, held at Good Shepherd in Loudonville on November 26 and followed by a pie reception.

• Lent and Holy Week services, including Ash Wednesday, Maundy Thursday, and Good Friday (both noon and 7pm); midweek soup suppers and Holden Evening Prayer with Albany Lutherans Together (ALT), which St. John's hosted twice; and our second annual Easter Vigil with ALT, hosted at Good Shepherd in Loudonville.

• Pride Sunday worship on June 9 with Upstate New York Synod Bishop Lee Miller preaching, followed by an amazing Lutheran turnout for the Capital Pride Parade & Festival.

• The return of "Mass on the Grass" in our outdoor worship space on October 6 for our Blessing of the Animals, featuring 5 dogs, 3 cats, and 1 stuffed animal.

• The "Christ Mass" (Christmas Eve), with special music by St. John's Collegium, including the return of Collegium alumni Mikayla Malenfant (soprano, now in her first year at the Crane School of Music at SUNY Potsdam) and William Peltz Smalley (bass and violin). # MUSIC DIRECTOR'S REPORT – Page 1

### SAINT JOHN'S COLLEGIUM

Looking back on 2024 and the past eight years since we founded Saint John's Collegium, it's well and good to reflect on how the beauty and richness of liturgical music has elevated the worship life of this congregation, and how our sacred musical education mission has been realized in our youngest members. Of our twelve musicians on Christmas Eve, three started training with us while they were yet in high school.

Before going off to earn a bachelors and a masters degree in violin in Boston and Montréal, **William Peltz Smalley** started playing and singing with us when he was a senior in high school. **Mikayla Malenfant**, last year's choral apprentice, just finished her first semester at the Crane School of Music. **Maura Lander**, our current high school apprentice, just passed her prescreenings and will soon perform her live auditions at Ithaca College, SUNY Fredonia, and Crane. (I hope that we'll always have at least one apprentice per year to continue and expand this invaluable ministry.)

Saint John's Collegium gave each of them a massive boost towards careers in music; they all love Saint John's so much that they tell me months in advance when they'll be home to ensure they get the most time with us during their breaks.

On November 24, St. John's Collegium premiered Music Director Dan Foster's new Thanksgiving Cantata – Psalm 136 – "Oh, give thanks to the Lord, for He is good!" Watch (or re-watch) it on <u>YouTube</u>! We should acknowledge and be thankful for how special this is, and how much beauty and goodwill we broadcast beyond these tiny walls, beyond our little choir.

Most of our 'older' choir members (the near 30/20-somethings) started when they were undergraduates at The College of Saint Rose (now sadly defunct). Saint John's Collegium gave them a huge a boost as well: in the greater community, our musicians are teaching, directing their own groups, and are first call gig artists for many other local conductors. Whenever other conductors hire our musicians, they know exactly where they've come from; our people are tremendous ambassadors for Saint's John's when they're out performing in the community.

When I think about the broad positive influence a community of faith can have, I can't help but be overjoyed with how well our choir continues to function not only as the sacred music leaders of this congregation, but far beyond. **Continued on page 15.**

### **TECHNICAL PROJECTS**

#### Sconces

Over the summer, I completed the custom cast-iron cross sconces; guest always ask about them; one of our congregants liked them so much that she bought the materials and I made one for her home. The bulbs we installed are app controlled over WiFi. On Christmas Eve. I was thrilled with how well that worked during the singing of Silent Night as I dimmed the lights from my phone as we lit our candles, just before I started to play the organ introduction. Together with the "stained glass" light covers that Pastor Josh installed over the fluorescent light fixtures, our lighting is now versatile, and truly beautiful.

#### Hardwiring

Hardwiring the audio video computer To make a more reliable stream for our remote worshipers, Pastor Josh and I realized that for greatest bandwidth and video stream stability, the MacMini at the AV station should be on wired internet, rather than WiFi. We took a couple days to run an ethernet cable through the walls and ceiling from the back corner of the sanctuary to the office, which was just as much fun as that sounds! We used our ladder time to clean out the overhead lights as well.



#### **Thermostat upgrade**

The wall on which the thermostat is mounted is uninsulated: cold air blows on it from inside the wall through a large hole (pictured below). As a result, it's impossible to maintain an even temperature in Winter. To solve this issue once and for all – and to gain the additional benefits of remote control and monitoring for the HVAC system - Pastor Josh and I decided to install a smart thermostat and remote sensors. But when we attempted to install it, we encountered a mis-wired condensate pump (pictured below) which led to the furnace shorting out and burning its safety fuse. I replaced the fuse, left a spare on the furnace, and cleaned out the condensate pump; when it gets warm enough for me to spend a couple hours down there without the heat on, I will rewire the mess pictured below onto a proper bus bar and complete the installation of the smart thermostat.

Appreciation is again extended to Robert (Bob) Curtis, Cemetery Superintendent, who handles sales, digging and responds to requests from Funeral Home Directors. The Superintendent and his crew also monitor the Cemetery grounds periodically, providing required repairs to broken headstones and other cemetery maintenance as needed.

For the second year in a row, we have contracted with Asprion Landscape LLC, a local Colonie business, for snow removal and salting, as Bob Curtis no longer has the capacity to provide this service.

We are in the process of having our cemetery records digitized by Lazarus Cemetery Mapping with the goal of having an easily searchable database utilizing the Cemify (software) platform. Lazarus was on site in August 2024 to capture data and plans to have data entry/transcription completed by late February/early March 2025.

Plans are currently being considered to build a separate Cemetery garage for all Cemetery equipment and an office for the Cemetery Superintendent. We will update you with more information as it becomes available.

# **RENOVATION TASK FORCE UPDATE**

A new Task Force has been established to assist Council regarding future building plans/ renovations consisting of Michael Centanni, Jerry Schwab and Karen Bielinski. The previous plans to build an entirely new campus (for the congregation, as approved at the October 2023 special meeting and reported at the January 2024 annual meeting) are being put on hold as the task force considers a more financially feasible and logistically practical renovation plan.

Initially, consideration has been given to the construction of a new cemetery garage and office on cemetery land to enable the renovation of the Chapel garages for additional office space and common area for the congregation, including a designated Sunday School area. All plans are preliminary and in discussion only at this time. The recommendations of the task force will be brought to Council and the Congregation for final approval. We are hopeful that an application for a building permit for the new garage building may be finalized for submission to the Town this winter, with construction to begin as early as this Spring (2025).

# TREASURER'S REPORT

The members of the finance team are: Melissa Savage (treasurer), Joy Pierle (assistant treasurer), Lindsay Stannard (president), Judy Carlson (bookkeeper), and the Rev. Josh Evans (pastor).

The finance team is responsible for preparing a proposed budget to be present to the Congregation Council and the congregation at the annual meeting. The team also monitors the investments of the congregation and makes recommendations to the council regarding investments considering the mission of the congregation.

During 2024, St. John's hired a third party bookkeeper to take on many duties the previous treasurer was completing. Judy Carlson joined the team in March and

has been a wonderful asset. The Treasurer now just maintains oversight of financial records, receipt and disbursement of funds, and acts as liaison between the bookkeeper and council.

Many other individuals assisted in the financial operations of the congregation throughout the year. Our thanks go to everyone who counted the offerings, posted pledge information and/or generated the contribution statements, as well as our congregation members who mailed their offerings, placed them in the offering plate at church, or submitted offerings electronically.

St. John's received a disbursement of \$156,000 from the Kane estate in June 2024 and the final disbursement of

\$22,744.96 (\$11,372.48 for each church and cemetery) from the Turner estate in November 2024. After a 10% tithing, the remaining balances have been invested in Certificates of Deposit, based on the interest rate environment at the time.

In preparation to complete the 2025 budget, fund consolidation was reviewed and approved to simplify the budget line items.

Our congregation's endowment continues to be managed by Fenimore Asset Management. The balances of the fund have increased in 2024 based on market conditions. We are still withdrawing \$20,000 each month from the Capital Reserve Account to cover St. John's monthly expenses.
